Waqf-e-Nau Addressed by Huzur atba



Hazrat Masroor says duty of Muslim youths is to serve society and to characterise Islam's peaceful teachings.

Hazrat Mirza Masroor Ahmad addressed the concluding session of the annual Ijtemas held for boys and girls at the Baitul Futuh mosque in London. More than 2,200 boys and girls attended these events organized on two separate occasions for the girls and boys. Huzur said the duty of Muslim youth was to serve society and to characterise Islams' peaceful teachings. On the topical issue on ISIS Huzur said :

"In today's world Islam is being defamed as a result of the actions of certain individuals who become radicalized and join extremist groups and organisations, which both preach extremism and carry out extremist acts. There are hundreds of youth who have left Britain and travelled to Iraq and Syria where they have joined the so-called Islamic organization known as ISIS or IS. These deluded youth may believe they are going to serve Islam, but in truth their actions have no connection whatsoever with the teachings of Islam "

When addressing the ladies convention, Hazrat Mirza Masroor Ahmad said that education was imperative and that It was completely wrong to suggest that Islam discouraged females from attaining a high level of education.

Hazrat Masroor Ahmad said:

"The Holy Prophet (peace be upon him) said that wisdom is like the best belonging of a believer—wherever it is found he or she should grab hold of it. Hence our women and girls, and in particular the Waqfat-e-Nau, should attain the highest standard of education and then they should strive to use that knowledge to give benefit to the world."

UN Designated Interfaith Harmony Week on ISIS



An AMJ NZ delegation attended the event organised by UPF on 7th Feb 2015. Maulana Shafiq ur Rehman spoke as the only Muslim speaker. He demolished any thought that the actions of ISIS, as reported, were even remotely called Islamic. He said we must look closely and investigate how it was possible for this group to continue and expand their war efforts for so long. How are they able to maintain their supply line, sell so much of oil in

black market and build up so many arms without direct or indirect support of some governments? This investigation is vital, as the only way to stop them was to break this supply line and expose the supporting hands. His speech was well received and acknowledged by the 35 odd guests from various inter-faith groups who attended. AMJ delegate also provided written literature and copies of DVD entitled "Eradicating Extremism", the keynote speech of Hazrat Mirza Masroor Ahmad^{aba}, the Head of the World-wide Ahmadiyya Muslim Community which he delivered at the 11th Peace Symposium, UK. - The following deductions may be made from the Gross Income from above sources:

- (i) Income Tax , ACC and other Insurance Contributions deducted under the PAYE system (ii) Council Rates paid to Local Council (iii) Any other Government Taxes on income. **To be continued.**
